During the 2014 – 2015 term we will endeavor to complete and continue those initiatives and projects as we have done in the past term.

At this writing, the many Camps of the Department have been and continue to be busy performing memorial services throughout the week of May 26th through May 31st. We commend you on your efforts to honor and keep green the memory of our Civil War soldiers and all vet



Its officers have attended many of these Camp-led ceremonies and we thank you for your Invitations to join in participation. We are usually overwhelmed with the number of requests made of the Department and sincerely apologize to those who made requests for which we were not able to support due to prior commitments.

The Department Secretary has been working diligently the past several weeks to complete the Form 35, the Department's Annual Report to the National Organization. In order for the Secretary to do his job, we MUST have ALL Forms 27 submitted to the Secretary by the required deadline. I am sad to report that four weeks past the deadline, we still have a number of Camps that are lacking in their reporting. The deficiencies range from inaccurate reporting, missing data, failure to make payment and simply seriously missed deadlines.

These deficiencies will no longer be tolerated. The National organization has drawn a line in the sand and will be suspending Departments who do not complete their reporting by the required deadlines. The Department of Michigan will not suffer suspension because Camps cannot or do not complete their reporting accurately, completely and by the deadline.

The Department will not hesitate to suspend a Camp that is not in compliance. It is unfortunate that we have come to this point, but please let all Camps be fully aware that there will be consequences regarding their reporting obligations.

The Department Secretary is always available to all Camp Commanders and Camp Secretaries to assist them with their reporting needs, advice and counsel. Please utilize his services. Further, all new Camp secretaries should be mentored by past Camp secretaries as to the requirements of their duties and the processes they must follow. In the next few days, the Department Secretary will once again send a communication to all Camp Commanders and Secretaries with a list of required Forms and the deadlines for their reporting. Please adhere faithfully to these requirements.

Nationally, the Department of Michigan enjoys an enviable position as a respected Department within the Order. Please help us to maintain that position of respect and honor.

The Department Secretary reports that for the current annual report we have 489 members in the Department of Michigan. This is down from the 505 reported last year. We lost 54 Brothers and gained 38 new Brothers. The number of new Brothers gained while encouraging, continues to lag behind our losses. This is a trend that has been noted over the past few years, and while not new should be a concern for all Camps as it is for the Department. Please continue to focus on your recruiting efforts so that we are sustaining our membership rather than continue to have it erode.

Lastly, we would like to mention once again that we have a vacancy concerning the Department's webmaster. To date there have been no mentions of possible candidates to fill this position. All Camps are requested to address this matter during your Camp meetings to see if a volunteer can be found. Also consider the possibility of the son of a Brother, a college student who needs a class project or a high school student who has the ability to maintain our website and needs community service credit.

The Department has exhausted several attempts to fill this need and has been largely unsuccessful. If we can not fill the position, it may be necessary to contract this service as an out of date, inaccurate website is something we can not afford.

On a happier note, we have had one Brother step forward to try and update certain parts of the website such as the Department Headquarters and contacts information. This is strictly on a short term basis. The thanks and appreciation of the Department for this individual's volunteering.

Thank you for your attention to these matters and as always, please do not hesitate to contact the Department for support in any matter for which you require assistance.

Brothers, decisions are made by those who attend and participate. Thank you for being there to help.

6. Having a current and correct Email address is essential for efficient communication within the Department. All Camps must have at least one person designated to receive Email messages from the Department. These communications, including Department Orders, General Department Communications, and the *Michigan's Messenger* newsletter.

If neither the Camp Commander nor the Camp Secretary has a valid Email address, Camp Commanders will please designate one person within your Camp to receive Email communications from the Department. These messages must then be passed along to those who need the information. Please inform the Department Secretary as to the person so designated.

Brother Danes reports again this year that many Brothers contact him saying they have not received the *Michigan's Messenger* newsletter. If you have a valid Email address, please send it to your Camp Secretary. Failing that, look on the Department website to download the newsletter.

Camp Secretaries, in the spirit of Fraternity, Charity, and Loyalty, for those Brothers who do not have computers or internet access, please consider printing out a paper copy of the communication or the *Messenger* and mailing it to those Brothers.

7. Once again there is a vacancy fo the Department Webmaster/Signals position. Having a Webmaster is important and necessary to insure accurate and timely communication. The Communications and Technology Committee will be charged with conducting a search to select a suitable Webmaster to fill the current opening.

In addition, we are asking all Camp Commanders to conduct a survey within their Camps for Brothers or sons of Brothers who would be able and willing to serve as Webmaster for the Department.

In the event that we are not able to find an individual to be the Webmaster on a volunteer basis, we may have to consider contracting this service. - 8. Memorial Day will be observed on May 26th and Decoration Day on May 30th. All Camps and all Brothers are encouraged to participate in some act of remembrance to mark this important day for Keeping Green the Memory of our Civil War ancestors. If you can join an activity with Brothers from your Camp, do so. If you are unable to participate in Camp activities, then consider a solo effort. Visit a cemetery and find the grave of a Civil War veteran, perhaps one that appears to have been forgotten. Make it your business to honor him place a flag and flowers on his grave much as our fore-fathers would have. Remember, both Memorial Day and Decoration Day are central to our obligations as Sons of Union Veterans to remember these soldiers, sailors, marines, and those from the cutter service of 1861 1865, and all veterans who have served to safeguard our Nation.
- 9. The National Encampment will be held this year in Marietta, Georgia on August 14th through August 17th. The site of the Encampment is the Hilton Atlanta Marietta Hotel and Conference Center. Hotel reservations and pre-registration materials are now available at <u>http://www.2014nationalencampment.com/</u>. The deadline for pre-registration is July 31st. Please join the Michigan Delegation to the National Encampment.
- 10. We are all compelled to address a most serious matter for the department of Michigan. While most of our Camps do an excellent job of submitting reports on time, we have a small number who are habitually tardy, especially with Forms 22 and 27. It is essential that the Department receive these and all reports on time and in an orderly fashion. The Department Secretary must review and manage the reports from all 24 Camps, and then prepare the Department Reports that are due to the National Officer on a specific date.

The National organization is becoming less tolerant of late reporting by the Departments. Suspension of Departments for failure to report on time is something that <u>will not</u> happen to the Department of Michigan! <u>Our</u> recourse as a Department is to suspend offending Camps within our Department. Please work with our Department officers, ask for help if you have a question or need assistance in completing your reports on time. We hope to never suspend a Camp for this non-compliance.

Patriotically Speaking

I would like to thank my Michigan Brothers for putting their faith in me for another year by appointing me Department Patriotic Instructor.

I was a bit disappointed that only 14 Camps reported patriotic activities for 2013. That is down from 17 in 2012 and from 20 in 2011.

Unfortunately that leads me to wonder why? Either the Camps do not think it is worth the time and effort to get the paperwork into the Department, or the Camps/Brothers are not doing the things we need to do as members of the SUVCW to express our patriotism.

The SUVCW is a patriotic organization, a group of men who gather in Fraternity, Charity, and Loyalty. But what do those words mean?

Fraternity is the state of quality of being brothers; fraternal relationship or spirit;

brotherliness. It is a group of men (or, sometimes, men and women) joined together

by common interests. Thus, the Auxiliary and the women of the WRC, LGAR and DUVCW are part of this expanded "family" of brothers and sisters who have come together to "keep green the memory of the Boys in Blue." We work together to advance knowledge of The Civil War 1861-1865 that saved our "union" of states from becoming two separate countries.

I consider The United States of America my home. It is a home of many families and many "fraternal" organizations that were established to make this country a better place. The SUVCW is one of the fraternal families that I belong to. I am a member of the SUVCW because of my ancestors who loved it enough to give their lives in nearly every war this country has been involved in. It is also for love of my country ... a country that despite its differences is striving to create a country and a world that is better. A country that – when I pledge allegiance – dedicates me and others "to liberty and justice for all."

Charity is something more difficult to define. Many religions have charity at the center of their theology. It is the love of God for man or of man for his fellow men. Charity is also an act of goodwill or affection. It is that feeling of goodwill; benevolence and kindness or leniency in judging others. It is also defined as voluntary giving of money or other help to those in need. It is the money of the help that is given. It is also an institution or other recipient and a welfare institution or organization or a fund. It is synonymous with the word "mercy."

Loyalty is more straightforward: it is a quality, state, or instance of being loyal; faithfulness or faithful adherence to a person, government, cause, duty, etc. It is synonymous with allegiance.

Having said all that, are we all being positive members of the SUVCW?

Do we work together like a family to achieve our stated goals or are we like a dysfunctional family that is constantly fighting or by our actions are pushing new members out of the organization or preventing others from joining because we don't want to be bothered with doing the paperwork or to take the time to involve new members? If a new member does not feel welcome or their help or contributions wanted they will walk away.

Are we expressing our patriotism in ways that are visible? Do we fly The Flag of the United States of America? Or is it something we do only on special Flag Days?

If, like me, you have a health situation that prevents you from marching in a parade ... think about getting a trailer that can be towed with brothers in the uniform of the order or Civil War dress/uniform. Involve your Auxiliary if you are fortunate to have one to support you in this effort. Invite members of the other Allied Orders to ride on the trailer with you. I belong to a small camp in Shiawassee County. Brother David Hilliker has personally built two replica cannons. We drape his trailer in red, white, blue bunting and three or four members ride on the trailer. We hang a banner on the trailer that identifies us as SUVCW Camp 160.

We participate in two or three Memorial Day parades in our area. We join together with DUVCW and ASUVCW for the Memorial Day Ceremonies. Sometimes we do nothing more than stand as the ceremonies take place. Other times we participate by firing the cannon. We all participate by our presence.

So, the questions remain: Are you showing your fraternity helping Brothers in the organization get their jobs done for the organization?

Are you being charitable to one another and helping each other learn and grow within the organization? Are you being loyal to your oath as members of the organization?

And finally ... how patriotic are you?

TAPS A Tribute to a Friend Submitted by Chris Czopek

John Lohrstorfer passed away on May 5.

John was one of the Charter Members of Camp 22. He served as Camp Commander a number of times. Also served as Camp secretary and treasurer (and he was always on time with his reports.)

John started our Graves Registration program back around 1992. This was "pre computers". He took a shoebox, cut file cards to fit, and then personally walked most of the cemeteries in Calhoun County, recording graves. When I joined the SUV, he had forty cards marked "unit - unknown". I started my career in Civil War soldier research working with him, identifying the units of men who were not in the Brown Books. In time we became good friends.

Couple other things - he had a remarkable career in the Michigan State Police. For his last duty station, Battle Creek, he was State Police Post Commander. He was also a veteran of World War II. He was an artillery-spotter, driving in a jeep AHEAD of the battle line, hiking to the top of a hill with a microphone, and calling in strikes on Panzer Tanks waiting in ambush. His Division, "The Rainbow Division", liberated the Dachau Concentration Camp. John drove his jeep there, the day it was liberated, and walked around. The sights he saw he never forgot. Had a picture of himself taken that day, standing under the infamous "Arbeit Mach Frei" iron gate. Few people know he was decorated for heroism under fire. Only way I found out, is when he showed me his uniform, I noticed the Bronze Star and asked him, "How did you get that?". He smiled a great big smile and told me the story. Only his closest friends have heard that tale.
