The 7th Michigan Infantry Over the past month, I have had the opportunity to review the Constitution and Regulations of our Order, and the Bylaws of our Department, to re-read past Encampment minutes, to talk with Past Department Commanders, to re-read and consider the Strategic Direction Report generated for the 117th Encampment, to consult with various current Department Officers, and review job requirements for those who do the work of the Order. I have asked myself what more can we do to make the Department of Michigan best able to carry on the work of the Order? Our Strategic Direction Report noted that, "the work of the Order happens in the Camps. The Department's function is to make available the tools necessary for the success of the Camp." That being the case, the main objectives of the Department become clear. It needs to be able to aid and assist the Camps in doing their work. Further, the Department needs to be as organized and efficient as it can be, so that it may perform this duty with as little expenditure of energy as possible, leaving more time for the Camps, and ultimately the brothers, to do the work of our Order. The goals I would like us to achieve during the next year focus on promoting those two ends.

First, it is my intent to see to it that those duties required of the Department are met. We have numerous reporting and activity requirements that we are called on to perform by certain times according to the C & R and our own Bylaws. While they are too numerous to list here, they are all necessary to the proper functioning of the Department and our obligations to our members, our Camps, and the National Organization. In many organizations these matters are referred to as "Housekeeping." My first goal is to make sure we keep our house in Order.

Second, over the past couple of years we have expressed concern at the Encampments that our Department Records have needed attention. We are an old Department and our *Continued on Page 2*

records go back many years. They have been stored in a lot of different places, with some of them being transferred annually from Department Commander to Department Commander. These records need to be centralized, catalogued, and in some cases preserved. In that way we can not only safeguard our own history, but can end concerns about problems that arise when you are wondering where all these things are, and what is going on with them. We have the work of the Order to do, and by properly seeing to our records, we free up time that would better be spent in doing that work. My second goal is to see that our Department Records are properly cared for.

Third, we have a Ceremonies and Rituals Committee which for several years has been inactive. This committee can help to promote the proper use of the Ritual in our Camps and at our ceremonies. Using technology we can produce a DVD that explains and encourages the use of our ritual at meetings and memorials we engage in. Said DVD would be distributed to the Camps for their use. Our rituals are one of the things we share in common with one another and one of the things that bind us to the veterans who used such rituals in the Posts of the Grand Army of the Republic. As such, we need to encourage their use as our link to each other and to our heritage. Further, as more and more Camps act with one another on joint projects, it would be of benefit to have them all familiar with the same way of doing things. Proper use of the ritual and support for Camp Guards, which are part of the charge of this Committee, will go a long way toward making this happen. My third goal involves the revitalization, at least to some extent, of the Ceremonies and Rituals Committee.

Fourth, the Department needs to facilitate the ability of Camps and Camp Officers, especially camps close to one another which may have the occasion to work on joint or regional projects, to easily communicate with each another. There have been several instances where Camps have joined together to take on regional projects or ceremonies, and support one another in their endeavors. My intent is to see to it that Camp Commanders and Secretaries have an up to date list of contact information for each other and have access to the news from their neighboring Camps. That way, if you wish to work on projects of regional importance, you have the tools at your fingertips to do so. My fourth goal involves increasing communications between neighboring Camps.

Fifth, the Department needs to help in the training of those Camp Officers who ask for it, on how to properly fulfill the duties of their offices. In the past, we have had a mid winter conference that was meant, in part, to achieve this goal. One of the problems we ran into with the mid winter was that very often the time demands or travel requirements on the people who needed the assistance the most, were such that they were unable to attend, and thereby take advantage of the advice of those who had performed the jobs before. Last year, we began exploring the possibilities of using teleconferencing to put our officers from all over the state in touch with one another. This worked well. In fact, so well that I propose using the same method to act as a training opportunity for those who are entering into a new job at their camp with which they may not be familiar. It will use current technology to overcome a problem presented to us before regarding time and distance. My intent is to start slowly and, if this appears to work, use it more and more to assist the new officers of our Camps in the discharge of their duties. I propose to start with the area in which we often have confusion, the job of the Secretary and how to deal with all those darned forms. My fifth goal is to use the technological

resources available to us to be sure the Camp Officers are comfortable in the duties they need to perform because they have been properly instructed.

Sixth, I would like to see all of our Camps with Web Sites keeping them current. If our Camp web sites are months or years out of date, it hinders others who may want to contact us to further the work of the Order, and makes us appear as a group that just doesn't care too much. This is one that we will be depending on the Camp Officers for the most help with. We can, at the Department level, offer assistance to you in keeping up this task. If you need expertise, we have people in the Order that can provide that. You need only ask. My sixth goal is to properly maintain our web sites.

Seventh, I intend to put together a mid term gathering. I would want to couple this gathering with an event or project of statewide importance to the task of helping to keep green the memory of the soldiers and sailors. Ideally such a gathering would be in the fall, would be to promote an event central to our commitment as Sons, and would involve time to be set aside to socialize with one another and catch up on what old friends from other areas of the state are doing. It is not exactly a revitalization of the old mid winter conference, but it contains many of the same aspects. My seventh goal is to put together such a gathering.

Eighth, I would like to see the Department support the Canadian Union Veteran's Civil War Monument currently being planned as a tribute to those soldiers and sailors who fought to preserve the American Union but who came in from Canada to do so. This is a project that is being pursued at the National Level of the Order. We, here in Michigan, share a long border and an even longer history with our Canadian cousins. Many of the men of this Department trace their ancestry to Canadians who fought for the Union in the Civil War. We are in a rather unique position among the Departments of the Order in this regard, and we should be doing something to help in the creation of this memorial. Our intent would be to offer assistance, such as we can, to further the aims of the

National Committee working to help create this monument. My

Eighth and final goal is to support the Canadian Union Veteran's Monument Project.

Various work of the Order goes on as well. The foregoing are new initiatives I intend to address this year. The fine work of the other offices within the Department, notably our GAR Records, Graves Registration, Monument Preservation, and Editing and Publishing of the Messenger, among others, continues. Those efforts are in the hands of capable Department Officers whose work is very much appreciated.

None of these goals happen without the work of the men of this Department. To that end, I am asking you to let me know if you have any special interest in any of these projects. If you have any special skills that would further these goals toward completion, your service to the Department in that respect would be appreciated. In short, I am asking for volunteers in carrying the Department forward in these areas. If you can help, please contact me. My email is p31713@aol.com.

I know it looks a bit ambitious, but brothers, there are over 500 of us and we've got a year. I'll keep you posted in the Messenger of the progress we are making. Come along and lend a hand and we'll make that progress happen faster than anyone could imagine.

As I write this, Memorial Day 2010 is upon us. I've just finished with seeing to it that American Flags are placed on Veterans graves at out local Fruitport Cemetery; I'm the current Post Commander of our Fruitport VFW post # 3734; a position that I've held several times in the past, we had the assistance of our Gerald R. Ford Council Boy Scout Troop # 1023 assisting us. As our post Veteran membership ages, the help of the Boy Scouts in seeing that veteran's graves are properly decorated is greatly appreciated.

I recall that at an early age my mother used to take me to the local Coopersville Cemetery to make sure that Veterans' gravesites had flags on them year round. She had worked out with the local sexton that flags placed for Memorial Day would be left on our family graves throughout the year.

When I came back from Iraq, my son was 2 and I started to take him along with me to follow in my Mother's footsteps. He's been by my side in this act of love ever since. In the Coopersville Cemetery is a veteran of the War of 1812; three from the Civil War (two from the 3rd Michigan Infantry and one from the 10th Michigan Cavalry); and two from WWII. My mother's grave is decorated with a bronze DAR marker, and she and my grandmother both have DUVCW markers (both members when my grandfather was alive and a member of the Coopersville GAR Post. My mother remembered telling her two brothers of my grandfather's Civil War service. As a member of the 3rd Michigan Infantry, he was at First Bull Run. My uncle, 1st Lt Max Reynolds was killed during the Battle Of the Bulge in 1945. He earned the Combat Infantryman's Badge and two Bronze Stars – I am named after him.

I relate the above as the basis in part for my strong feelings towards Memorial Day and what it means to us in the SUVCW; it is up to us, the Sons of Union Veterans of the Civil War, to do our part to keep alive the memories and service of those Veterans who have preceded us in life.

Seeing to it that American Flags are placed on graves, especially on Memorial Day, but also year round is one way that we can do that. I spent 32 years in the military; two wars – Viet Nam and Iraq; and someday the time will come when it will be someonr elses turn to pick up where I and others have left off. Think about installing in your children and other youths the importance of Memorial Day and what it means; ask them to continue the tradition of placing flags both now and in the future. And don't forget to mark the grave sites of the DAR, the SAR, the DUVCW, and those other patriots who have served their country in their own manner. God bless them all, and long live our Constitutional Republic!

Greetings to all.

Well, with the winter-time excitement with the new VA and National guidelines behind us, it seems that all Camps are "back to business as usual" in ordering headstones. We must remember, **all headstones that are ordered by SUVCW Brothers, and not by a descendent or a cemetery manager, sextant, or township official must be approved by me**. Send a copy of the documentation that you are sending to the VA, and I will respond asap by e-mail so that we do not hold up your program. The full Headstone ordering policy can be found on the National website under Policies.

The Department Database contains a little over 62,000 records as of today. Because Brother Adair is up north on a degree study trip, we will not update our on line site until September. At that time I will ask Matt to create two databases – one for Civil War veterans only, and a second for "other wars" veterans that we record (Rev War – Span Am). The Committee has discussed this issue many times, and it is a good way to retain our Excel database and not cause our committee members a hardship in that they would otherwise need to purchase and learn how to use an alternative software.

The June Committee Meeting was postponed until July 17, same place, same time as in the past.

I will be presenting the Graves Registration Program to the Calhoun County Genealogical Society at 7 PM on July 22.

Budget Cuts Shut Down Another Historic Treasure

I would like to thank each and every one of you for your efforts in helping to voice your opinions to the Detroit City Council about the recently proposed budget cuts. I am aware that there was difficulty for some of you to get through the complaint link on the City of Detroit website. Many were able to get their messages through to support the Fort we love so much and our partners in the City of Detroit Parks and Recreation Department. Thank you again for all of your time and efforts doing this.

Unfortunately, Tom was not able to speak directly to the City Council as hoped. Tom did run into several friends and supporters along the way which helped get him as close to the Council chambers as possible. There were very few people allowed into the Council chambers before the voting had taken place. Rest assured Tom did his very best to represent your voices and Fort Wayne.

Equally unfortunate, the Detroit City Council had the majority votes needed to override Mayor Bing's veto of the proposed FY2010/2011 City Budget. This included the additional \$1 million reduction in funding to the Parks and Recreation Department. Without much choice left to be had, cuts will be made and Fort Wayne Detroit will most likely be closed to the public as of July 1, 2010.

Now this is certainly saddening news for all of us. We will be seeking further guidance and clarification of our role on site at Fort Wayne. Maintaining a positive relationship with our partners in the City of Detroit, we do not anticipate to be asked to vacate the site due to this imminent closure. However, we intend to continue to offer our services on site in helping the City maintain Fort Wayne.

We must keep our chins up and stay the course. It is important now, more than ever, to not give up hope. I will continue to keep you updated with further news and information as I receive it.

The organization Pillars of Honor which conducts grave registration work and obtains necessary replacement tombstones has asked us to conduct re-dedication ceremonies for Civil War Veterans in cemeteries north of Coopersville in Muskegon County where they obtained new tombstones. We agreed to conduct the rededication ceremonies. But we also wondered due to all the new more detailed SUVCW regulations to obtain replacement tombstones if our camp and the Pillars of Honor could work together on this project. So we have asked a member of the Pillars of Honor to attend one of our meetings this summer to talk about their organization and discuss this proposal.

We also have been looking into the condition or lack of tombstones in the cemeteries of Eastmanville, Lakeshore and Nunica in Ottawa County and Norton Shores in Muskegon County.

Meanwhile Brother Daniel Grable, a member of the Spring Lake Heritage Festival Committee, while conducting historical research for the committee found minutes of the parent organization mentioning the actual vandalism of the Noah Perkins GAR Post #279 of Spring Lake monument and the cemetery it was located in. The Township replaced it with a tombstone style stone with the same information as the original monument. The footing is still there and the Camp would like to replace the old monument with a new monument in the style of the original monument. Work on this will continue.

Also two brothers of our camp and members of the Charles A. Conklin American Legion Post #28 in Grand Haven Ken Kelly and Max Rieskie are co-chairing the committee to erect a Fallen Veterans Monument for the area north of the Grand River/M-45 in northern Ottawa County covering the wars of World War II to Iraq-Afghanistan Wars and any in the future. It will be placed in Central Park in Grand Haven with the Ottawa County World War I monument. Also on the committee is our Camp Commander Richard Scott. They are currently working on raising funds for the monument and if you would like to contribute or know of any names needed to be included on the monument please contact any of our brothers involved in this project. On May 9th Brothers Daniel Grable, Donald Ogden, Cliff Owen, Jon Scott, Richard Scott made classroom presentations to the eighth graders in the Harbor Lights Middle School of the West Ottawa School District in the Holland area. Brother Grable presented a talk on the camp's namesake Henry E. On Saturday several brothers of the camp traveled out to the gravesite of our namesake Henry E. Plant to pay our respects to Henry and those of his family buried there. Kenneth Kelly is the Adjutant for the Grand Haven Memorial Association and the local American Legion Post.

7th Michigan Volunteer Infantry Regiment

Our next installment of the regimental history series is the 7th Michigan. This regiment was gathered together in Monroe, MI and left for the eastern theater of the war on September 5, 1861. The regiment consists of the following companies: Co A., Union Guard of Port Huron, Co B, Curtenius Guard of Mason, Co C Jonesville Light Guard of Jonesville, Co D Monroe Light Guard of Monroe, Co E Tuscola Volunteers of Tuscola, Co F Blair Guard of Farmington, Co G Lapeer Guard of Lapeer, Co H (name unknown) of Pontiac, Co I Prairieville Rangers of Prairieville and Co K Burr Oak Rangers of Burr Oak. My Camp is named from Company B from Mason, the Curtenius Guard.

The original commander was Col. Ira R. Grosvenor, who resigned following the battle of Bull Run. The regiment was the commanded by Col. Norman J. Hall of Michigan, a captain in the 5th US Artillery, a graduate of West Point. His commission was dated from July 7, 1862.

The regiment followed McClellan to the Peninsula in the spring of 1862 and suffered severe loss while participating in the engagements at Yorktown, West Point, Fair Oaks, Peach Orchard and Savage Station, White Oak Swamp and Glendale and then Malvern Hill. The regiment was also engaged at 2nd Bull Run.

In the battle of Antietam, more than half of its force engaged was disabled. At Fredericksburg on December 13, while serving in Col Hall's brigade, the regiment volunteered to dislodge rebel sharpshooters who were impeding the construction of the bridges. They crossed the Rappahannock for that purpose and with the aid of the 19th Massachusetts, drove the enemy from their hiding places, capturing nearly as many prisoners as they numbered themselves. The 7th Michigan Volunteer reenactment group has erected a monument at the point where the 7th Michigan crossed the river, the only Michigan monument at Fredericksburg.

The regiment served provost duty for some time at Falmouth. While they were present at the second battle of Fredericksburg, they were not engaged. They suffered light casualties at Chancellorsville.

The regiment engaged in a number of forced marches in it's attempt to reach Gettysburg, rendered more arduous by the intense heat. They marched 75 miles in three days marching, one march being 32 miles in 12 hours. They arrived on the field July 2 and immediately went into line in front of Cemetery Hill, where they remained through the 4th. They were heavily engaged on both the 2nd and 3rd and among their losses was their commander, Lt. Col. Amos E. Steele. His grandson is a member of Curtenius Guard Camp 17.

The 7th Michigan engaged in the chase of the rebel army, crossing the Potomac, through the London valley to Manassas Gap. On August 20, they embarked on steamers to New York city, returning to the Army on September 7. After engaging in light skirmishing with the enemy through their time into winter quarters at Barry's Hill. 162 members of the regiment reenlisted, whence the regiment returned to Monroe, arriving on January 2, 1864, where they received a 30 day furlough. The regiment returned to the Army of the Potomac in time to be engaged at the Wilderness and Spottsylvania Court House.

After enduring all of the marches of the Army of the Potomac, they then endured the trenches at Petersburg. They were involved at various posts and then took part in the chase of Lee's army as it fled west. After the surrender, the regiment was ordered to Richmond and then to Washington, where they participated in the grand review. The regiment was then transferred to the Army of the Tennessee, where they did provost duty at Louisville, KY until July 5, when they were mustered out. The regiment traveled back to Michigan, arriving at Jackson on July 7, where they were paid off and disbanded.

There was a total of 1,393 men in the regiment, losing 6 officers and 123 men killed in action, died of wounds 5 officers and 47 men. 3 officers and 154 men died of disease.
