In Memoriam

Lowell Herbert Orebaugh

5 February 1901 ~ 14 April 1997

Camp 14 in the Traverse City area, until recently could boast having one of the oldest Members of the SUVCW, age 96 and one of the youngest, age 17. Unfortunately, this duo was broken by the death of Lowell Herbert Orebaugh, April 14, 1997, one of the few remaining "true" sons of a Civil War Veteran. The youngest part of the duo is Camp Secretary, Jacob Bennett of Bellaire.

The wide range of ages spans almost eighty years and demonstrates the broad interest descendants have in honoring the heroic commitment and patriotism our forebearers displayed in offering their very lives to save the Union. Although a basically a modest man, Lowell was very proud of his father's Civil War record which included three terms of enlistment in the Union Army as a musician. Band music often was an important morale builder in lifting the spirit and courage of men approaching a deadly battle condition and the musicians also shared the danger.

For several years prior to Lowell's coming of age at 21, he received a small monthly government check as a dependent of a deceased Civil War veteran. His status as a "true" son resulted from his father Alfred marrying at age 63, his mother, Maggie (Day) age 32.

Quoting from his obituary:

"Lowell H. Orebaugh, 96, died peacefully in his sleep at home, Tuesday morning, without illness."

"He was born in Marathon, Ohio on February 5, 1901, the son of Alfred and Maggie (Day) Orebaugh."

"... (his father) twice voted for Abraham Lincoln."

"Lowell was educated at Miami University in Oxford, Ohio where he met his future wife, Esther Louise Hunt, who preceded him in death in 1982 after 56 years of marriage"

"He retired in 1962 as a Chief Inspector for the U. S. Departments of Treasury and Justice in Traverse City." Lowell was a member of the Sons of the American Revolution, the Sons of Union Veterans of the Civil War and the Society of Descendants of Washington's Army at Valley Forge."

"During his years of retirement, he enjoyed reading Civil War history, gardening and, until recently, would plan and prepare full course dinners for his family and friends every Sunday. Lowell was one of the few people who have been privileged to have seen Haley's Comet twice. He was able to live almost completely unassisted, with his loving cats, until the day he died."

His remains were buried beside those of his wife in Grandview Cemetery in Salem, Ohio. Camp 14 provided a SUVCW grave marker. It was a great privilege to have known Lowell. He will be greatly missed.



SUVCW UNITES WITH SCV AT CONFEDERATE VETERAN'S GRAVE

In 1861, 16 year old John Hall Reed joined the 14th Mississippi Infantry to fight for the Southern cause. After the war he studied medicine in Philadelphia, eventually establishing a practice in Mississippi. In 1893 he brought his ailing wife to the Kellogg Sanitarium in Battle Creek, seeking a cure. Deciding to stay, he established a medical practice there and became a respected member of the city.

Excerpts from his 1908 obituary indicate why he was honored by Civil War veterans in Battle Creek. The military tribute could only have come from the many local members of the GAR.

"A Confederate Flag, colors under which Dr. Reed was a valiant fighter, covered one end of his casket, and joined its folds with Old Glory, draped above the dead soldier, citizen, physician and friend."

"The procession wended its way to the cemetery to the sounds of muffled drum beats, and at the grave, taps and reveille were sounded, the military air predominating the services." "He fought under General Bragg in many of the hardest battles. Since that time he became a loyal citizen of the Republic and discarded the Confederate cause forever."

The existence of Dr. Reed's grave in Battle Creek was discovered by Brother John Lohrstorfer of Camp 22 during his research of veterans grave in the Oak Hill Cemetery. George Olivier, who attends the Civil War Roundtable breakfasts in Jackson, learned of the grave and together with Bill Lowe of Camp No. 7, visited the cemetery.

Colegrove-Woodruff Camp 22 and Austin Blair Camp 7, were honored to participate with George Olivier, from the Sons of Confederate Veterans, Noah H. Fauver Camp 1448, in placing a flag at Dr. Reed's grave. (George, a Vietnam Veteran was wounded on three separate occasions during his tour of duty and is now on total disability as a result of the wounds.)

Both Camps look forward to assisting Mr. Olivier and the SCV in placing a military headstone on Dr. Reed's grave when it arrives.

All Brothers are urged to come with their families and friends to share in this outstanding event.
- 13. Plan also to participate in the 1998 Mid-Winter Conference. It will be held on Saturday, 21 February, again at the Midway Hotel at Lansing. An informative program of interest not only to Camp officers, but to all Brothers will take place. As a Department, we will host the annual Abraham Lincoln/George Washington Commemorative Banquet which is held jointly with the Sons of the Revolution in the State of Michigan.
- 14. I have the sad duty to direct that all Camp Charters be draped for a period of thirty days mourning for a late Brother, Lowell Herbert Orebaugh, who passed away in April at the age of 95. A True or Real Son, Brother Orebaugh of Traverse City was a Member of Robert Finch Camp 14. His father, Albert Orebaugh, served in the Union Army from 1861 to 1865.

15. All Camps are reminded about the Constitution and Regulation's Article IX concerning Camp Bylaws. It requires Camps to adopt Bylaws subject to the approval of the Department Commander. That Article also provides that no Camp Bylaws, amendments, alterations or deletions shall be effective until approved by the Department Commander in writing. The several new Camps, as well as the others need to keep aware of this article.

16. Remember to display your American Flag proudly! Display it on any day, but especially on the following days during the next three months: Labor Day, 1 September; Constitution Day, 17 September; Columbus Day, 12 October; Discoverers' Day, 13 October; and Navy Day, 27 October.

To help the Scouts, their parents and the public make the connection of why we award this certificate, I have included the following message in a cover letter that's presented with the commendation at the Court-of-Honor ceremonies I've attended. 
to you for your consideration and use. It reads, "In addition to honoring the memory of American Civil War Soldiers and Sailors who served the *Union*, our organization, the Sons of Union Veterans of the Civil War (SUVCW), carries on the traditions of the Grand Army of the Republic (GAR). The GAR was a patriotic and fraternal organization, similar in pur-

ganization, similar in purpose to today's veterans' groups (VFW/American Legion). One of the GAR's traditions was the promotion of good citizenship. Therefore, it is the honor of the SUVCW to present this *Commendation* to you, in recognition of your community contribution in the course of earning the rank of *Eagle Scout*."

Computer related communication is another option that we need to utilize further. Many of us do not own a computer, nor do we have access to one, but we cannot ignore the ever increasing number of folks out there that do seek out information over the Internet. I encourage each Camp to furnish material, per the example available on our Department's web-page, linked from the national site. I hope that *all* Camps will comply. A complete listing will offer any interested party the information he needs to contact an officer of the Camp nearest him (by telephone,

mail or even e-mail). Our Department's Communication and Technology Committee is staffed by some very talented Brothers, dedicated to serving our interests in the most professional manner. Another aspect of the Internet information that deserves our attention is getting what's out there into the hands of our membership who don't have access. For instance, our National Counselor (our own Bro. James Pahl) has posted the U. S. Flag Code on the National SUVCW web-site. This is something that each Camp's Patriotic Instructor could and should share with his membership - if he had it. There is a good deal of excellent reference material on the National site, not readily found elsewhere and I hope those Camps with someone "on-line" will print out this kind of information and distribute copies to their membership. 
Now, what to put our written communications on brings up the subject of "Standardized Stationary". There may be more to share about this after the up-coming National Encampment.

A SUMMARY OF THE

108th Annual Encampment \sim Michigan Department SUVCW

7 June 1997

There were 53 Brothers in attendance, including Senior Vice Commander-in-Chief Richard Orr. Three Brothers had pre-registered, but did not attend.

Camps represented were: 1, General John A. Logan, Grand Rapids; 7, Gov. Austin Blair, Jackson; 17 Curtenius Guard, Lansing/Sunfield; 20, Benjamin Pritchard, Kalamazoo; 22 Colegrove-Woodruff, Marshall; 53, Wa-Bu-No, Mt. Pleasant/Sheperd; 58, George W. Anderson, DeWitt; 67, General Phil Kearney, Bay City; 120, Gilluly-Kingsley, Howell; 145, Gov. Henry Crapo, Flint; 160, Henry F. Wallace, Corunna; and 266, James and Albert Lyon, Menominee.

In addition to Brother Orr, other Brothers holding positions within the National organization were: Kent L. Armstrong, Chairman, National "Save Outdoor Sculpture" Special Committee; Richard Greene, National Aide to the National Camp and Department Organizer; Keith G. Harrison, Past C-in-C, National Aide to the National Secretary; Hon. James B. Pahl, National Counselor; L. Dean Lamphere Jr., National Department-at-Large Secretary/Treasurer; Terrance L. McKinch, Chairman, National Military Affairs Committee; J. Douglas Park, Program and Policy Committee; Richard A. Williams, National Membership List Coordinator.

The following Officer recommendations were made and adopted:

Department Commander Wallace:

- 1. Redefine the position of the Commanding Officer of the Department Color Guard (30th Michigan Infantry ~ Sons of Veterans Reserve) as the "Military Liaison" between the Department and the current military component within the Department.
- Create a standing staff appointed position of "Signals Officer". This position would have the responsibilities outlined for the Communications and Technology Officer appointed at the beginning of this term.
- 3. Recommend that the incoming Commander appoint a Brother to the position of "Scouting Coordinator of Boy Scouts of America, Inc.". this position would have the responsibilities outlined for the Eagle Scout Certificate Coordinator, plus additional duties as the Department Liaison with the various Scouting Councils across the state.
- 4. Rename the position of "Aide" to Aide de Camp" in keeping with current National Organization terminology.
- 5. Redefine the Allied Orders "Weekend of Remembrance" Special Committee as a Standing Committee of the Department.
- 6. Subject to budget constraints, purchase of a large handheld scanner for the use of the GAR Records Committee.

- 7. Subject to budget constraints, purchase a four-drawer fire resistant file cabinet (new or used) for use in the archives of the Grand Army of the Republic Hall in Marshall.
- 8. Adoption of a Pre-registration program for all subsequent Department Encampments, establishing a \$5.00 pre-registration fee, with an \$8.00 "at the door" fee. Such fees to be reviewed and revised annually by the Department Encampment.
- 9. Adoption of an increase in the Department Per-Capita Tax of \$.75 per member per quarter or \$3.00 per member per annum, to be effective 1 January 1998.

Department Junior Vice Commander Armstrong:

A Proposal for a professionally produced National SUVCW "Recruiting Video" be sent as a resolution of this Department to the National Encampment in August.

Editor, Michigan's Messenger, Mann:

- 1. Obtain other bids on printing to reduce the cost of printing the newsletter. This has been accomplished.
- 2. Make format changes to increase the amount of printed information on each page at the editor's discretion.
- Reduce the number of pages to 12 or 16 requiring priority decisions on what copy to include or omit at the editor's discretion.

The following Committee recommendations were made and adopted:

Bylaws Committee:

1. ARTICLE III ~ OFFICERS AND THEIR DUTIES

Section 1. The elected Officers of the Department shall be as follows: Commander, Senior Vice Commander, Junior Vice Commander, three (3) members of the Council, a Secretary and a Treasurer. They shall serve for the term of one (1) year or until their successors are duly elected and installed. The Commander and the Treasurer or Secretary/Treasurer shall not serve on the Council. The same member may hold the office of Secretary and the office of Treasurer simultaneously.

Section 2. The Commander, after his election, shall appoint other officers for a term of one (1) year as per the Constitution and Regulations (C & R). the appointed officers shall include, but not be limited to, the following: Chief of Staff, Patriotic Instructor, Chaplain, Counselor, Organizer, Historian, Graves Registration Officer, Civil War Memorials Officer, GAR Records Officer, Communications and Technology Officer, Guide, Color Bearer, Guard, Aide, and other positions required by the C & R, Ritual, Department Bylaws and the orders of the Commander. The officers shall have such other duties which are prescribed in the official Department Officer's Job Descriptions as adopted by the National Encampment.

A SUMMARY OF THE

108th Annual Encampment \sim Michigan Department SUVCW 7 June 1997

Article IX ~ Committees

Section 1. The Standing Committees of the Department shall be as follows: Bylaws, Legislative, Membership, Graves Registration, Civil War Memorials, GAR Records, and Communications and Technology.

Section 2. Special Committees may be created by action of the Commander and shall exist for the period of time designated in the creation thereof. Duties and responsibilities shall be defined at the time of Committee creation.

Section 7. The Graves Registration Committee shall seek and identify all graves of Civil War veterans in the State of Michigan. The Committee shall bring to the attention of the Department any disrespect or lack of attention shown to any Civil War grave. The Committee shall be chaired by the Graves Registration Officer

Section 8. The Civil War Memorials Committee shall seek and identify all monuments and memorials dedicated to Civil War veterans and the Grand Army of the Republic in the State of Michigan. The Committee shall bring to the attention of the Department any disrespect or lack of attention shown to any Civil War monument or memorial. The Committee shall be chaired by the GAR Monuments and Memorials Officer.

Section 9. The GAR Records Committee shall seek, locate, catalog and promote preservation of all surviving GAR records in the State of Michigan. The Committee shall be chaired by the GAR Records Officer.

Section 10. The Communications and Technology Committee shall advise the Department Officers and Committees about the latest computer and related technologies pertinent to the Department. The Committee shall be chaired by the Communications and Technology Officer.

Communications and Technology Committee Recommendations approved:

- If Geocities offers web space and an e-mail address with no hidden costs and that its use would not be detrimental to the Order, the Department's Communications and Technology Committee be authorized to assist Camps in establishing individual accounts with Geocities Server.
- 2. Failing the Geocities proposal, that the Department authorize the expenditure of a sum, not to exceed \$150.00 per year, to cover costs associated with administering a five megabyte Department web page with Century Telephone Company. Should individual Camps and the Allied Orders desire, they be allowed to purchase additional web space on this server through the Department at the rate of \$1.00 per megabyte per month.
- 3. Where practical, Camps should be encouraged to establish their own Internet and web page accounts whether they be with individual members.
- 4. To insure uniformity and compliance with proposed National guidelines, the Department's Communications and Tech-

nology Committee should be authorized to review and approve independently developed Camp web pages for appearance and content before they are presented as representing a Camp of the Department of Michigan.

GAR Memorials Subcommittee Recommendations approved:

- That the subcommittee become a separate, standing committee.
- 2. That it be named "Memorial Committee". This was changed to Civil War Memorials Committee.

GAR Records Committee (Temporary) Recommendations approved:

- 1. That the Department of Michigan establish this committee as a new Standing Committee.
- 2. That a temporary Committee be established to study and develop a program to record all members, past and present, and their Civil War ancestors. This work should proceed under the direction of the Department Historian and consistent with the advice of the Department Counselor relative to security concerns for personal data.

Legislative Committee Recommendation approved:

1. That all Brothers are urged to contact their State House Representative to solicit support for House Bill 4713 for renaming M-99 as the General John A. Logan Memorial Highway.

Weekend of Remembrance Special Committee Recommendation approved:

 That all Brothers are encouraged to attend this special event.

Resolutions Committee Recommendation approved:

1. Resolved; that this Department endorses the candidacy of these following Brothers for election to National Office: Senior Vice Commander-in-Chief Richard Orr for Commander-in-Chief; Junior Vice Commander-in-Chief Andrew Johnson for Senior Vice Commander-in-Chief; National Chief of Staff David Turpin for Junior Vice Commander-in-Chief.

New Business:

Past Commander-in-Chief Harrison moved that this Department move the National SUVCW to donate a portion of the existing funds that are proceeds from the SUVCW-sponsored Military Ball held annually in conjunction with the Order's Remembrance Day ceremonies in Gettysburg, PA to the National Military Park there and further, that this donation continue to be made annually. — Approved.

Dandrow stated that there were six Michigan Infantry regiments engaged at Antietam. According to him, no accurate list of men from these regiments who died there exists, therefore any monument that is to be erected there should only list the regiments that fought there instead of the soldiers names. Dandrow is asking for aide from veterans organizations in his quest for an Antietam monument to Michigan soldiers.

HENRY E. PLANT

We also obtained for the Camp a U. S. Flag that was flown over the Capitol in honor of Henry E. Plant. It will be formally presented at the September meeting.

Another project we have been working on is finding out how and hopefully, getting a road in Crockery Township (Plant's home area) named for Henry E. Plant (our Camp's namesake and Ottawa County's only Medal of Honor recipient serving from the county).

The Camp has been very busy getting our name out and telling the community about the Civil War. We are doing this by getting up school programs for Ottawa County schools (this is also a fund-raiser). We present these programs in full uniform with weapons and equipment and where permission has been granted, give firing demonstrations using blank ammunition.

This summer we are participating with the 4th Michigan reenactors in having uniformed Civil War personnel at the Gerald Ford Presidential Museum on Saturday afternoons.

In August, the Camp is planning our annual Camp Picnic. This will be possibly in conjunction with a rededication of Henry E. Plants grave if the previously mentioned work is completed in Nunica Cemetery.

Besides all this outside work, the Camp decided to give our newly inducted members a bronze brotherhood recognition button, along with a tri-color membership certificate.

The Camp's next meeting is September 14th at the Tri-Cities Historical Museum in Grand Haven at 1:30 pm.

Henry P. Gillespie

Private (Fifer)
13th Michigan Infantry, Company A

Great Grandfather
of

Gen. Benjamin Pritchard Camp No. 20

Henry P. Gillespie was born June 22, 1847 in Lagrange County Indiana. He was a twin to his sister Henrietta. Henry was the son of Rev. Enoch and Mary (Kilmer) Gillespie. They had thirteen children including two sets of twins and one set of triplets. The family lived in Indiana until 1852, when they moved to the Sturgis, Michigan area in St. Joseph County, where Henry's father served as Elder for the United Church of God. In 1861 Henry's four older brothers enlisted in the Army for service in the Civil War. Brothers Ira, Martin and Enoch served in the 11th Michigan Infantry, while Levi served in the 13th Michigan Infantry. Brother Enoch would later serve in the 13th Michigan also.

Henry enlisted as a musician (Fifer) in Company A, 13th Michigan Infantry on March 15, 1865 at Kalamazoo. He said he was 18, but he actually was 17 years and 9 months old at the time. Early in the war his older brother Ira had given him a little sword that he had thought the world of, according to an account in the *Diary of Ira Gillespie of the 11th Michigan Infantry* (published by Central Michigan University Press, 1965). When he was finally old enough to become a soldier, Henry stood 5' 11" tall and had blue eyes and light hair.

Henry served most of his service time in West Virginia and Louisville, Kentucky. One story that he told my Aunt Elva (Henry's granddaughter, born in 1899) was that the 13th Michigan had been marching a long time and it was hot, so they decided to stop by a stream and fill their canteens. After they drank they marched upstream where they encountered a dead mule in the water they had drank from.

Henry mustered out at Louisville, Kentucky on July 25, 1865. On July 29th, the 13th Michigan Infantry was paid off and disbanded in Jackson, Michigan.

After the war Henry moved to Lacota, in Van Buren County. On December 2, 1872 he united in marriage to Almeda Faulkner in Bangor, Michigan. He was a farmer and also served

as Justice of the Peace. On October 31, 1892 at the age of 44 Henry joined the John H. Andrews Post No. 288 of the GAR in Lacota. He served as Adjutant of the Post for 18 years, from 1893 to 1913, except for the years 1904 and 1905, when he was Commander of the Post, the meeting were held at Clark's Grocery Store. The Post was organized in 1890 and was disbanded in 1913.

In June of 1893 he helped organize and served as secretary for the Soldiers and Sailors reunion in western Allegan and Van Buren Counties. The reunions ran for over 40 years. General Pritchard also attended this reunion once in 1902, giving the address.

On Memorial Day my aunt said, "You could hear the fife and drum corps playing Civil War songs as they rode along in their horse and buggy close to the town." She said her brother would cock his head and say, "I can hear Grandpa on the fife."

Henry attended the 50th anniversary observation of the Battle of Chickamauga in 1913, held in Kalamazoo to honor the Soldiers of the 13th Michigan Infantry who served in that battle. In 1915 he attended and was listed as Past Post Commander in the 37th Department of Michigan Encampment or the GAR held in Kalamazoo. He was a member of Zach Chandler Post No. 35 of South Haven at the time. He attended many GAR and 13th Michigan reunions.

I was told that he really enjoyed the 1909 National Encampment in Salt Lake City, Utah. While there, he played the fife as a member of the National Association of Civil War Musicians and represented the Department of Michigan as a delegate.

On June 14, 1919, just eight days short of his 72nd birthday, he passed away at his home a little south of Pullman, in Allegan County of Bright's Disease. He was buried in the Lindsley Cemetery, in Cheshire Township, with a soldiers headstone and a GAR flag holder marking his grave.

~ Memorial Day Postcards ~

The earliest of these types of postcards usually had a matte (flat) finish and were of an earlier, generally more crude style of design and printing. These cards all had an undivided back. By 1909 the styles had changed, the designs being better drawn and printed and having a semi-gloss or gloss finish. The reverse was now divided, the left half for the message and the right for the address and stamp with a distinct printedn dividing line. As is typical of postcards of the era, most were quite colorful. One characteristic of nearly all of the cards is the embossing of a part of the printed design. The embossing ranged from light to very heavy on some of the laminated cards.

As the public began to purchase more and more of the Memorial Day postcards, more publishers got into the act by designing their own cards and in some cases, copying the designs of others, outright or altering them slightly. Many of the postcards were printed in Germany (Winsch, Bein and Finkenrath) or England (Tuck) and imported into this country.

Several of the publishers also altered the design, the text or both and printed very similar postcards for other patriotic holidays, such as the 4th of July, Lincoln's Birthday and Washington's Birthday. Some also eliminated all text referring to a holiday and printed the postcard as a general patriotic greeting postcard, good for sales any time of the year.

Most of the postcards were printed in sets of usually four, six, ten or twelve. Some of the smaller publishers sold only individual cards, while the bigger publishers such as Tuck and International Art printed different sets every year for a number of years. There are over 20 identified publishers of these cards and several more that are unidentified because of lack of any name or logo anywhere on the card. There are over 350 different postcards that have a Memorial Day theme or that are part of a set having a tie-in with Memorial Day.

In addition to the Memorial Day type postcard, there were an untold amount of postcard designs printed for the various veteran organizations and their auxiliaries, the Grand Army of the Republic Members being the most prolific purchasers of this type. These postcards range from the photo type of parades, encampments, buildings and monuments, to artist drawn designs featuring monuments, buildings, etc., and artistic type invitations to various meetings, encampments and parades.
