#### **Photo Submissions**

Why Actual Photos Are Necessary

Briefly, the reason electronic photo files are not used is three fold. 1st, My printer is not of a high enough quality to print a photo that is good to be "shot" by the print shop to make a halftone for offset press printing. Unless an inkjet or laser printer can print at very high quality of TRUE photo quality, 2400 dpi (dot per inch) or higher, the result looks muddy when converted to halftone.

2nd, the quality of electronic files varies tremendously, especially those taken with digital cameras. A minimum resolution of 3 mega pixels should be used for 4 x 6 photos, especially if they are to be cropped and the cropped area enlarge. What looks acceptable on a computer screen doesn't necessarily look good in print.

3rd, the print shop can take the electronic file and convert it directly to a halftone, but that doubles the processing cost per photo. The Messenger already consumes a major portion of the Department's budget and by having everyone snail mail their photos, the result is the Messenger is a higher quality product and cost the Department (you, our members) less to print. We save money for other activities.

- 5. Thanks are also extended to Lucille "Peaches" Streeter, President of the Woman's Relief Corps, and Nancy Newman, President of the Daughters of Union Veterans of the Civil War, for the many courtesies extended to me as our paths have crossed this year. It has been enjoyable working with them.
- 6. Camp Commanders are reminded to PLEASE be sure your annual reports are completed and sent in to the Department Secretary on time. - 8. The Kalamazoo Valley Museum, located on Rose Street in downtown Kalamazoo, has an outstanding Civil War exhibit until May 30. It is a merger of a traveling exhibit from Ohio, and items from the museums own collection. Included are the Spencer carbine leveled at Jefferson Davis by Cpl. Munger of the 4th Michigan Cavalry, and items from soldiers of the 13th, 19th and 25th Michigan Infantries. There is also a display of items from Orcutt Post No. 79 of Kalamazoo. Included in this is a flag from Sons of Veterans Camp 70, of Wakeshma Two. In the text of the display, the Sons of Union Veterans is mentioned several times. I would encourage you to make a trip to Kalamazoo to view this exhibit
- 9. In closing, I would like to thank the brothers of the Department of Michigan for your support during this year in office. I am confident the department will continue to be the model for the rest of the Order of the Sons of Union Veterans of the Civil War.



## **Graves Registration**

#### Greetings, Brothers

This past weekend, I had the honor of chairing the twentieth meeting of the current Graves Registration Committee... think of that for a minute... the Committee has now been successfully doing the work of the Order as a <u>TEAM</u> for six years. After being conceived by PC-in-C Kent Armstrong, and initiated by PDC Hayes, we have served PDC Hayes for two terms, PDC Butgereit for two terms, and DC Gibson for one term. We hope that future Commanders have the confidence in our efforts to allow our direction to be continued.

But I digress.... at that time (the last meeting) I gave each attending Camp Officer an updated copy of the Graves Registration database on CD, containing over 50,200 records. At the meeting 10 Camps were represented, all reporting some success in our work.

What is very satisfying news is that Camps 20, 7, 120, 14, 139, and 2 (in addition, Camps 101 and 427 will collaborate on several opportunities this year) all have new headstones or monuments that will be dedicated or rededicated this spring. Unfortunately, several major events are scheduled on the same weekends, so we can't attend all of them. Of course this is not a primary responsibility of the Graves Committee, but the need for most of the work of this nature comes from the Committee's surveys. If your Camp will be rededicating or dedicating this year, let me know, and I will send out a note through the GRO E-mail Network. I do want to mention several members who are doing excellent work; Brother Jim Harris (and his son Brother Timothy Harris) is not only surveying and documenting Oakland County, but photographing each Civil War Soldier's headstone as a permanent record; Brother Matt Adair has kick-started the work in Genesee County, reviewing and submitting many never-before recorded records from that area; Brother Chris Czopek continues the task of documenting all Michigan men who died at Andersonville; Brother Dick and Sister Mary Hutchins completed some very important work in Lake County this summer, and are preparing a sequel to their book; and Brother Bill Lowe, who like an experienced orchestra director continues to organize our friends outside the Order to survey and report areas not previously done, such as the UP outside of Camp 266, the upper central part of the lower, and the central counties that border Ohio. I also would like to welcome our newest Committee Member, Brother Bill Miller from Camp 17.

I do want to reflect on a recurring subject of mine. The Committee has submitted and recorded over 4000 records this year with less than 50% of the Camps participating. I wonder what we could do with a true <u>TEAM</u> effort? There is still plenty of time for the Camps who have not been able to survey or report graves to get on board. We still have over half of the state to survey (gee, 50% of the Camps....50% of the state!) so there is plenty of area to go around.

The National Database has gone online, with over 600,000 records now available to the public. This is a great accomplishment for the Sons, and is a major way for us to spotlight our efforts.

My annual report will reflect that we have over 50,700 records in the Department DB.

Thank you all for your support and efforts.

# Robert Finch Camp # 14 ~ Traverse City

January to March 2005 Report Submitted by Wm. E. Skillman, Camp Commander

The membership rolls for Robert Finch Camp #14 shows 45 Members, of whom 11 are Associates. Visiting brothers are welcome to join our meetings at the Elks Club on 625 Bay Street (at the intersection of Division/Grandview Parkway). Our next meeting is scheduled to start at noon, May 7, 2005.

Dept. Commander Gary Gibson and Camp 20 Secretary Charles Worley made the long drive from Kalamazoo to Traverse City to install the Camp officers during the January meeting. Commander Gibson also announced the challenge from General John Logan Camp No. 1 to pledge \$5.00/member toward the purchase of new flags for the Michigan soldier's graves at Gettysburg. The Camp promptly raised \$105.00 and we anticipate that the \$225 goal will be met during the March meeting.

Camp #14 is pleased to announce that we have raised \$78,000 for the Grand Traverse Soldier Restoration Project in Traverse City. We are only \$2,000 short of our original goal of \$80,000. In December the monument was dismantled and transported to Karkadoulias Bronze Works in Cincinnati, Ohio where it is undergoing restoration. The success of the fundraising venture (started on May 25, 2004) was only possible through the untiring efforts of our volunteers, both from Camp 14 and the community. The lion's share of credit goes to Executive Director Breaugh, whose steadfast leadership kept the project on track and on time. We especially want to recognize the timely contributions from the National Park Service and Grand Traverse Band of Ottawa & Chippewa Indians whose grants arrived simultaneously (February 1) and will pay off the outstanding restoration costs.

Camp #14 extends an open invitation to all SUVCW brothers and families to attend the Rededication ceremony on Memorial Day, May 30<sup>th</sup>, from noon to 1 p.m. on the 86<sup>th</sup> District Court House grounds, (Washington and Boardman streets). The ceremony coincides with the 115<sup>th</sup> anniversary of the original dedication of the Soldier monument by the citizens of Traverse City to her GAR veterans.

Camp #14 was pleased to welcome National Auxiliary SUVCW President Michelle Langley (of Interlaken, New York). She addressed both Camp 14 and our own Frances Finch Auxiliary Camp 9 during the March meeting.


